I. Roll Call

The Regional Intergovernmental Council met on December 10, 2020 via GoToMeeting. Roll Call was taken by Amy Talbert, Deputy Executive Director. Chair Cunningham declared a quorum and called the meeting to order.

II. Executive Director's Report

Colt Sandoro, Executive Director, gave a summary of projects and updates for the past quarter:

Community Development

Kanawha County

- The RIC staff is working with the Kanawha County RDA, which received final approvals to bid the Paint Creek/Standard/Mahan waterline extension that provides added water and fire service to the West Virginia Turnpike restaurants and fuel stations.

- The RIC staff is working with Kanawha PSD, which received the final \$1.5 million from the USDA Rural Development to fund this \$7.9 million project that will provide sanitary sewer to the Lens Creek area of Kanawha County.
- The RIC staff is working with the Town of Cedar Grove, which received bids on their Sanitary Sewer Rehabilitation project and will begin construction in the early spring.
- The RIC staff is working with Yeager Airport, which received a \$1.3 million US EDA grant to construct to apron for the Marshall University Flight School and provide sanitary sewer to outparcels for acquisition.

Putnam County

- The RIC Staff is working with the Putnam Public Service District, which received a \$1.2 million US EDA grant to rebuild water capacity for its system that will add or retain vital employment in Putnam County.

Transportation

- Hazardous Intersection Study: The RIC staff reviewed the final reports for four of the five intersection/corridors that were studied. The staff held the final Steering Committee Meeting to review countermeasures for the fifth intersection, Montrose Drive and MacCorkle Avenue. The countermeasures were well received and the study is expected to be completed by the end of the year.
- Metropolitan Transportation Plan (MTP): The RIC staff worked with Kimley Horn to host two virtual public meetings, update the travel demand model and is now in the beginning stages of project identification.
- Performance Targets: The RIC staff has been working with WVDOH, KRT and WVDPT to prepare updated performance targets for next year.

Terry Martin, Project Coordinator, provided an update on the HUD grant programs and the Appalachian Regional Commission grant program. No action was requested.

On July 1, 2021 Acting Chairman Snodgrass will become Chairman Snodgrass and the time he served as acting chairman will not count against his tenure once he becomes chairman.
